## IN RE NIGERIA CHARTER FLIGHT CONTRACT LITIGATION

### INSTRUCTIONS

1. Please print all information carefully. If the information you provide is incomplete or cannot be read, your claim may be rejected. A check will be sent to the name and address that appears on this Claim Form.

2. In order to make a claim, you must include with this Claim Form a copy of your World Airways ticket, a Release and an Affidavit. If you no longer have your ticket, you may submit alternative documentation to prove that you have a valid claim. Examples of alternative documentation include credit card bills, a copy of your passport or tourist visa showing entry into the United States or Nigeria at the relevant time or any other documents that tend to show you are a valid claimant. If you submit alternative documentation your claim will be considered, but please note that an airline ticket is considered the best evidence of a valid claim and should be provided if possible. You **must** fill out the accompanying Release and Affidavit and have your signature on those two documents witnessed by either a Notary Public or a Commissioner of Oaths qualified in your country of residence.

3. For each claim that you make you must fill out a *separate* Claim Form, and include the appropriate World Airways ticket (or alternative documentation), Release and Affidavit. For example, you must fill out a separate Claim Form for any qualifying children. If your child is too young to execute the required documents, including the Claim Form, Release and Affidavit, a parent or legal guardian may execute the documents on behalf of, and in the name of, the child.
